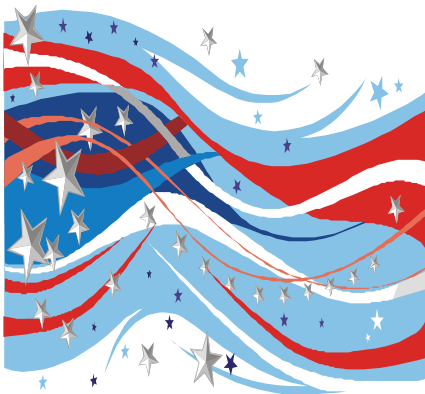

Effective July 1, 2008\*, Pacific Homecare Services will increase Respite Provider pay rates to the following new rates:

Three Child Rate	\$15.18 an hour
Four Child Rate	\$17.24 an hour
